Hybrid recommender systems. Feature Augmentation: One recommendation technique is used to compute a feature or set of features, which is then part of the input to the next technique. Cascade: Recommenders are given strict priority, with the lower priority ones breaking ties in the scoring of the higher ones.

Practice Requirements for Nurse Practitioners

The Collaborative Practice Rule states that the Missouri State Board of Nursing has the right and duty to discipline advanced practice registered nurses for "violations of any state or federal statutes, rules, or regulations regardless of the licensee's participation in a collaborative practice arrangement" [see (4)(G) of rule].
